Public Pension/Health Care Study

Led by our Government Affairs Committee, with the purpose being to better understand the current status of unfunded public pension and

health care liabilities facing our County, SCCBC began work on this project in the early part of 2012 and continued it throughout the year. Our aim in commissioning a comprehensive look into this topic was to publish an accurate, timely and useful report that would



useful report that would Joe Nation be used as a tool in the budgetary and policy decision-making process throughout the county, cities and special districts.

CA and Metro Economic Forecast



For the third straight year, we have served as a "gold-level" sponsor of the quarterly economic forecast published by the Business Forecasting Center at the University of Pacific. Our support allows for the Santa Cruz County Metro-area to be included as one of the ten metro areas individually analyzed each quarter. The *CA and Metro Economic Forecast* is distributed to SCCBC members as it is published each quarter.

Government Affairs

Local Election Forums

In order to provide our members with a chance to meet and listen to candidates, and to introduce business issues to the political arena, SCCBC co-sponsored public forums for Santa Cruz City Council and Santa Cruz County Supervisor candidates. SCCBC worked with other local business-focused organizations to coordinate these events, as well as to formulate business-centric questions for the candidates to answer. These forums were broadcast countywide through Community TV (CTV).

Advocacy

Each year, SCCBC closely monitors the local landscape for projects that support economic vitality in the community. After careful research and consultation with member organizations, we will advocate for development and improvements that enhance the local business climate. 2013 Work Plan by Committee Infrastructure

Committee Objective: To advocate for infrastructure countywide that will support business growth and development.

Committee oversees:

- All policy matters related to development/ planning
- Transportation issues/topics
- Advocacy
- Committee meets once per quarter with the SCCRTC

Focus Areas:

- County Water Supply/Desalination
- Highway 1 Progress Future Phases
- Rail Line/Trail Project

Government Affairs/Economic Development

Committee Objective: To work with County, municipal and special district leadership to promote business-friendly policies, as well as effective and efficient agency work practices.

- Governmental relations with all elected and administrative officials
- Public policy analysis

Focus Areas:

Government Relations

SCCBC will continue to foster a close relationship between the business community and our public officials. By building a strong private/public partnership, the private sector will be able to clearly and directly communicate with public officials about policy issues affecting the business community. The goal is to meet with officials from all public agencies on a regular basis throughout the year.

Public Pension and Health Care Liability

Continued from 2012, SCCBC will continue to monitor the local landscape, visit with public officials about potential reforms/solutions and will produce a follow-up "white paper" (collaboration with the Business Forecasting Center) analyzing different aspects of this topic.

Homelessness in Santa Cruz County

This Committee will continue to work with the Smart Solutions group (comprised of 25 business professionals from across the County) to develop strategies to effectively combat the issue of homelessness in Santa Cruz County.

2013 CA & Metro Economic Forecast (Business Forecasting Center - University of Pacific)

Our goal for 2013 is to use this data, not only to inform our membership, but to leverage it on a broader scale throughout the County.

Membership

Committee Objective: To ensure that SCCBC members receive a return on their investment in the organization.

- Public educational forums and member events
- Community partnerships
- Member communications (e-newsletter, business briefings, etc.)

Focus Areas:

Member Investment

The Membership Committee will be placing emphasis on communicating with each SCCBC business to determine the specific needs of each member. The purpose is to ensure that each organization receives the return on investment they seek by being a member of SCCBC

Community Collaborations

In 2013, SCCBC will be working with UCSC to help strengthening the relationship between UCSC and the County business community. The first step in this endeavor will be a public forum to be held in early summer.

Educational Forums

Starting in late spring, the 2013 *Lunch and Learn* series will commence. The year's series will focus on health care policy, the local and statewide economic forecast for 2014, homelessness in Santa Cruz County, and the aforementioned program focusing on the private sector working in tandem with UCSC.
